

## BID NOTICE UNDER OPEN DOMESTIC BIDDING

Upon payment, interested bidders shall then submit the bank deposit slips to UDBL front office /reception at 1st Floor Rwenzori Towers, Wing B, Plot 6 Nakasero Road, Kampala. Interested bidders shall be required to share official e-mail accounts where the PDF copy of the Bid document should be shared.
- 6. Bids must be delivered to the address below at 8(b) at or before 11:00am (local time). All bids must be accompanied by a bid security of UGX 8,000,000 (Uganda Shillings Eight Million Only). Bid securities must be valid until 30<sup>th</sup> December 2021. Late bids shall be rejected. Public bid opening shall be restricted in conformity with the Standard operating procedures issues by Ministry of Health in response to COVID 19 pandemic as per the terms and conditions indicated in the bidding document.
